## **Integrated Children's Services Plan**

Production of the ICSP was delayed until the end of June, however Councils now have more time to produce this due to Covid-19

Falkirk Council's Integrated Children's Services Plan is underpinned by Joint Strategic Needs Assessment developed by Community Planning Improvement Group. Information will also be provided by Falkirk Council CLD groups and from CYP engagement through CYPIC project all of which will inform the next ICSP and plans going forwards.

- Mental Wellbeing
- Poverty
- Family Support
- Children's Rights

### **CYPIC update**

A collaborative project with the Children and Young Peoples Improvement Collaborative was undertaken earlier in the year. 2 3<sup>rd</sup> sector representatives (Scott Malcolm, CVS Falkirk and Geoff Reid from Sacro) along with Jude Breslin and Mark Meechan from Falkirk Council attended training from Scottish Government and Children in Scotland on Improvement Science.

- The aim was to co-design Falkirk's ICSP with 200 Children's and Young People
- We used open questions to gather Qualitative data and pulled themes from responses using Thematic Analysis.
- There were 211 responses: there were 13 responses from 3<sup>rd</sup> sector and 198 from CLD groups
- We asked groups to facilitate sessions with CYP and to feed back the results
- The results have now been collated and we are now at the stage of analysing the results and looking for themes or trends.
- Unfortunately there was a low level of responses from 3<sup>rd</sup> sector due to Covid (important because 3<sup>rd</sup> sector organisations represent some of the most marginalised sections of the community and these are the people who should be feeding in to ICSP via 3rs sector orgs). Increasing responses from CYP through 3<sup>rd</sup> sector organisations is a priority for future engagement
- 1<sup>st</sup> test of change towards a true co-production model with CYP this will be ongoing
- Currently info is being collated, and we are now analysing

**Next meeting** – The groups felt that more regular meetings would be beneficial, in the short term, to bring the group back together. A period of 3-4 weeks was discussed.

- Best Start Grants school age payment £250 one off payment (1<sup>st</sup> June 28<sup>th</sup>
  February) Applicants should be in receipt of Universal credit or income support Extend windows for applying for best start which include payments for Baby,
  Nursery and School and children
- Young carers grant up to age 19
- Funeral support payment
- If people cant apply online they can call a number and get a call back!
