We might see children's rights resulting in a raising of the age of criminal responsibility over time.

a.iv Parental Employment Support Fund (PESF) - Information for parents

Are you a working parent aiming for the next step on the career ladder?

Do you need help to do this?

We may be able to help you if you are in any of these eligible groups:

- Lone parent
- Black, Asian and Minority Ethnic
- Youngest child under 1 year
- Parent aged under 25
- Disabled parent
- Parent with 3+ children

PESF is voluntary and offers person-centred help for parents to look at their barriers to progressing in work.

This might include:

- Support to gain a qualification
- Help with improving skills or work experience
- Money advice
- Motivational support

To be eligible for PESF, you need to be in one of the target groups, have the right to live and work in the UK and need some in-work support.

b. Notes from Falkirk Child Protection Committee - 21/10/2020

Young People and mental health

Anecdotally GP's and CAMHS not seeing a significant increase in referrals but difficult to get data.

There has been an increase in adult inpatients in adult mental health services by adults not previously known to services

School nurses have noticed an increase in referrals related to mental heath

• Equal Protection Bill

Police have received additional training. Will have an impact on front line policing. There will be a number of areas the Police will consider on whether to charge and/or proceed to IRD including if the the child is on the CPR or the adult has been convicted of domestic abuse. Police expect to see an increase in IRD and joint interview of children but IRD will not be the default.

 There new national guidance on conducting Significant Case Reviews out for consultation ending on the 25/11/. There will be a Forth Valley response

CP learning and improvement

- Learning Summary for Child D will be shared on the National Knowledge Hub
- Education and Health are still undertaking the learning sessions
- Increase in OLLE child protection training update has been seen across all service areas

- GIRFEC materials all being refreshed and rolled out with training. Focus on assessment of need and risk





- Number of children on the register has fallen from 52 to 42 in the last quarter but still significantly higher than the national average
- There was an audit and some findings: 1. all were appropriately registered. 2. There could have been more effective multi-agency working in 13% 3. Some pre-birth assessments have revealed that older siblings have been at risk. 79% already had SW involvement for some time before registration.
- There are significant improvements in meeting timescales this quarter with 60% of ICPCC on time (previous quarter was 38%). 70% of initial core groups on time
- Team Around the Child will be the next area to be scrutinised. Parents have not been invited to TAC or CPCC but this will change as using Microsoft Teams to facilitate. Face to face have been paused.
- There are significant staffing shortages in staffing in health visitors, school nurses and social work. This impacts the whole system. Everyone is asked to be persistent in efforts to share information where there are CP or welfare concerns

3. Organisational Updates

a. Allan Robertson Social Security Scotland

Scottish Child Payment – money for any child under age 6 (no cap on amount of children) – opening early to avoid too many applications at once – open now! – first payments by end February

SG – support for families with disabled children £200 towards fuel for heating – highest rate DLA care component – people don't need to apply they get it automatically
