FUND GUIDANCE





What is it?

The Falkirk Communities Mental Health and Wellbeing (CMHWPB) Fund aims to support community-based projects and initiatives to help address local mental health and wellbeing needs for adults across Falkirk communities.

Managed and distributed by CVS Falkirk & District, the Fund has a strong focus on **prevention and early intervention** and aims to support local activities tackling mental health inequalities and addressing priority issues of **social isolation and loneliness, suicide prevention and tackling poverty and inequality** with an emphasis on responding to the ongoing cost of living crisis and on those facing socioeconomic disadvantage.



How much is it?

With approximately £130,000 available, there are three grant types you can apply for:

- **Small:** Up to £2000 for un-constituted groups, otherwise up to £5000
- **Medium:** Up to £10,000
- **Large:** Up to £25,000

Please note you can only make **one application** per group or organisation across any of the grant levels (small/medium/large). If you received a grant offer letter for two year funding in the previous round, you cannot apply to this round.



The Timeline

The Fund will open for applications for all sizes of grants on Tuesday 1 September 2026 – and all applications must be submitted by 1pm on Tuesday 13 October 2026.

CVS Falkirk & District must distribute funds for 2027/28 to successful applicants before Tuesday 31 March 2027. Based on applicant feedback from previous years, we anticipate decisions will be shared in December 2026 with grants being paid in January 2027.

Can I apply?

Eligible organisations include:

- Scottish Charitable Incorporated Organisations (SCIO)
- Unincorporated Association
- Companies Limited by Guarantee
- Trust
- Not-for-profit company or asset locked company or Community Interest Company (CIC)
- Cooperative and Community Benefit Society
- Community Council
- Parent Council

Please note:

Un-constituted groups are eligible to apply, although the way you manage your award, if successful, may look a little different. For more information, please contact us by email: info@cvsfalkirk.org.uk
